Councilor Carney explained that he voted no on this at the last meeting because he was concerned about the immediate family language in the ordinance. On roll call vote for final passage, the bill passed unanimously. Council President Lonergan declared Council Bill No. 3076 duly passed.

LOTTERY BOND GRANT AGREEMENT

Morris/Ellsworth... award a Contract for administration of 457(b) and 401(a) deferred compensation retirement plans and associated services to ICMA-RC and authorize the City Administrator to sign the Agreement. The motion passed unanimously.

COMMUNITY CENTER FUNDING

Morris/Ellsworth... support earmarking the proceeds from the sale of City owned property, located at 1750 Park Ave for use in developing construction documents for the community center project.. The motion passed unanimously.

CITY ADMINISTRATOR'S REPORT

City Administrator Derickson introduced Community Relations Manager Gutierrez who invited Council to the Community Celebration happening this weekend at the Plaza.

MAYOR AND COUNCIL REPORTS

Council Morris stated that he has heard numerous complaints about the school district and that he is concerned about it.
