### WOODDUMPUBLIC LIBRARY

### **Youth Reading-for-Fines Policy**

Woodburn youth patrons (age 17 and under) may read away their overdue fines. This process is made available to facilitate access to library materials when: borrowing privileges are suspended due to overdue fines on the youth patron's individual account; and to otherwise offset any financial burden that overdue fines may represent to a family or household.

#### **Procedure:**

- Youth patrons wanting to read for fines must check in with library staff at the youth services desk.
- The patron who will be reading for fines must be seated at a space designated by library staff.
- Patrons should bring or select their own book(s) to read during the agreed-upon reading period.
- Patrons must read for a minimum of 15 minutes and a maximum of 30 minute in one session.
- Reading times must be agreed upon in advance and will be tracked by a timer.
- At the end of the reading period, library staff will waive \$1.00 from the youth patron's individual account for each 15 minutes that the patron read with intent.
- <u>Patrons must actively read</u>. For this reason, we strongly encourage participants to select reading material that is enjoyable.
- If patrons are not actively reading, youth services staff will warn the patron that the time period may not qualify for a waiving of fines.
- Repeated failure to successfully complete a reading-for-fines session may prevent future participation in the reading-for-fines program.
